No. KHR-2017-136-FAC-142017-477446-M(3):- The following draft of rules which is proposed to be issued under sub-section (1) of section 6 read with section 112 of the Factories Act, 1948 (LXIII of 1948) is published as required by sub-section (1) of section 115 of the aforesaid Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration by the Government of Gujarat on or after the expiry of forty five days from the date of its publication in the *Official Gazette*.

2. Any objection or suggestion which may be received by the Principal Secretary, Labour and Employment Department, Gandhinagar from any person with respect to said draft on or before the expiry of the aforesaid period will be considered by the Government.

**Draft Notification**

No. KHR-2017-136-FAC-142017-477446-M(3):- In exercise of the powers conferred by sub-section (1) of section 6 read with section 112 of the Factories Act, 1948 (LXIII of 1948), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Factories Rules, 1963, namely:-

1. These rules may be called the Gujarat Factories (Fourth Amendment) Rules, 2017.
2. In the Gujarat Factories Rules, 1963, for existing rule 8A the following rule shall be substituted, namely:-

**"8A. When licence deemed to be granted or renewed.-**

Where an application for grant or renewal of licence is duly made in accordance with these rules, the factory in respect of which the licence is to be granted or renewed, as the case may be, shall be granted or renewed, as the case may be, shall be deemed to be duly licensed until such licence is granted or renewed until no order is communicated to such person or an intimation regarding that the

grant or renewal of the licence had been refused is communicated to such person within ninety days.

*Explanation:-* (1) For the purpose of this rule an application for the grant or renewal of a licence shall be deemed to have been duly made only if it is in the form specified therefor and is filled in with all relevant particulars and further is accompanied by a treasury receipt, a crossed cheque, a crossed Indian Postal Order or as the case may be, an invoice for book adjustment, for payment of the fees in accordance with the Schedule annexed to Rule 4.

(2) Ninety days shall be calculated from date of expiry of the licence."
